LICENCED PROVIDERS: HOW WE USE YOUR PERSONAL INFORMATION

We, the Water Industry Commission for Scotland, (the Commission), registered at Water Industry Commission for Scotland, First Floor, Moray House, Forthside Way, Stirling, FK8 1QZ, are committed to collecting and using data fairly and in accordance with the requirements of the General Data Protection Regulation (EU) 2016/679 and the Data Protection Act 2018 (the Data Protection Laws).

We are the controller of the personal information that we hold about you. This means that we are legally responsible for how we hold and use personal information about you. It also means that we are required to comply with Data Protection Laws when holding and using your personal information. This includes providing you with the details contained within this statement of how we hold and use your personal information, who we may share it with and your rights in relation to your personal information.

We have appointed a Data Protection Officer (DPO), who ensures that we comply with Data Protection Laws. If you have any questions about this statement or how we hold or use your personal information, please contact the DPO via email at: DPO@watercommission.co.uk.

WHAT PERSONAL INFORMATION DO WE HOLD AND USE ABOUT YOU?

As a licence holder of a water services licence and / or a sewerage services licence, we hold and use the personal information that you provide to us and / or other personal information that we may obtain about you from you and from third parties on an ongoing basis. This includes your:

- name;
- contact information;
- financial information; and
- criminal records information.

If you do not provide us with the above personal information, you may not continue to be a Licenced Provider.

WHY DO WE HOLD AND USE THIS PERSONAL INFORMATION ABOUT YOU?

We use such personal information to:

- maintain an up-to-date register of licences;
- keep records and manage and administer the licensing process;
- calculate the licence fees and process our invoices for the same; and
- protect and defend our legal rights in the case of a dispute between us.

WHAT IS OUR LEGAL BASIS FOR HOLDING AND USING YOUR PERSONAL INFORMATION?

Data Protection Laws require us to have a legal reason for holding and using your personal information. Our legal reason for holding and using your personal information is to manage and administer water services and / or sewerage services licences as part of exercising the official authority vested in us in terms of the Water Services etc. (Scotland) Act 2005 and associated legislation. We also hold and use your personal information to comply with other legal and regulatory obligations that apply to us.

WHO DO WE SHARE YOUR PERSONAL INFORMATION WITH?

We may share your personal information with the following organisations for the purposes described in section 2 of this statement:

- Scottish Water;
- Scottish Government;
- Scottish Environment Protection Agency;
- Drinking Water Quality Regulator;
- Central Market Agency;
- our consultants and IT service providers; and
- our solicitors.

HOW LONG DO WE KEEP YOUR PERSONAL INFORMATION?

We will only keep your personal information for as long as we need to for the purposes described in section 2 of this statement, including to meet any legal, accounting, reporting or regulatory requirements. More information is contained in our data retention policy, which is available by contacting our DPO.

WHERE IS YOUR PERSONAL INFORMATION TRANSFERRED TO?

Our servers are located in the European Union and the information that we collect directly from you will be stored in these servers. We may also transfer parts of your personal information, where reasonably necessary, to our third-party service providers who may be located outside of the EU or who may engage sub-processors located outside of the EU.

WHAT RIGHTS DO YOU HAVE IN RELATION TO YOUR PERSONAL INFORMATION THAT WE HOLD AND USE?

It is important that the personal information that we hold about you is accurate and current. Please keep us informed of any changes. Under certain circumstances, the law gives you the right to request:

- a copy of your personal information and to check that we are holding and using it in accordance with legal requirements;
- correction of any incomplete or inaccurate personal information that we hold about you;
- deletion of your personal information where it is no longer necessary for us to continue to hold and use it;
- temporarily suspend the use of your personal information, for example, if you want us to check that it is correct or the reason for processing it or to stop us from using your personal information altogether if we have committed a breach of Data Protection Laws; and
- the transfer of the personal information that you have provided to us to you or to another organisation; and
- that you are not subject to a decision solely taken by computer which produces legal consequences for or otherwise significantly affects you.

You can also object to us holding and using your personal information on grounds relating to your particular situation, unless we have overriding and compelling legitimate grounds for holding and using your personal information in certain situations.

TRANSPARENCY STATEMENT: LICENCED PROVIDERS

Please contact our DPO if you wish to make any of the above requests. When you make a request, we may ask you for specific information to help us confirm your identity for security reasons. You will not need to pay a fee when you make any of the above requests, but we may charge a reasonable fee or refuse to comply if your request for access is clearly unfounded or excessive.

FEEDBACK AND COMPLAINTS

We welcome your feedback on how we hold and use your personal information, and this can be sent to our DPO.
